



2009 USEF YOUTH/PONY PILOT PROGRAM CLINICS

USEF will be hosting up to eight (8) Youth/Pony clinics throughout the United States as part of the USEF Youth/Pony Pilot program directed by Lendon Gray. Lendon Gray will be conducting clinics throughout the US at various farms. In addition, several US High Performance Riders will be hosting and conducting clinics at their own facility. Each training session will have lessons focusing on seat and use of aids and private lessons. The two day sessions will also have practice test riding. Each rider will leave with a written evaluation and suggestions for improvement. There may be lectures at each session as well.

Applicants should meet the following criteria:

Received at least two (2) scores at 62% or higher from two (2) different judges:

Riders 13 and under on horse or pony at First Level and above

Riders 15 and under on horse or pony at First Level and above

Riders 17 and under at Third Level and above

If space permits, Rider 20 and under at Fourth Level and above

To be considered for one of the **November 21-22, 2009** USEF Youth/Pony Clinics, this application and all supporting documents must be completed in full and received by the USEF Dressage Department no later than **November 11, 2009**.

To be considered for one of the **December 2009 or January 2010** USEF Youth/Pony Clinics, this application and all supporting documents must be completed in full and received by the USEF Dressage Department no later than **November 20, 2009**.
