#### Reminder for 2024!

Individual Invitations - The next twenty (20) highest ranked athlete/horse combinations, from the Junior Jumper National Championships National Standings List, who have not been selected to a Zone Team or as the Zone's Traveling Reserve will be invited to compete as an Individual.

Individuals will compete in Phase I, both rounds of Phase II, and are eligible for Phase III in accordance with the specifications (top 60% overall from Phases I and II who have not been eliminated during either Phase are eligible for Phase III).

How will the 5 Member Youth Nations Cup Final Teams be Selected?

- Up to the top three (3) U.S. Athletes/Horse combinations, provided they are on the podium (1st, 2nd, 3rd) in the Final Overall Standings of the Young Rider or Junior age category at NAYC.
- Two (2) athlete/horse combinations will be recommended to the Team by the Chef d'Equipe. Participation at NAYC is not a requirement for Discretionary Selection, however, performance at NAYC is strongly considered.
- If any of the top three (3) U.S. Athlete/Horse combinations are not on the podium, selection for this position will revert to Discretionary Selection.

## **Clean Sport Reminder**

FEI Athletes – please be reminded that human IV Infusions or injections of more than 100 ml within a 12-hour period are prohibited per WADA and FEI Rules unless the infused/injected substance is administered during a hospital treatment, surgical procedure or clinical diagnostic investigation.

Therefore, athletes should always apply for a Therapeutic Use Exemption (TUE), if they are administered an intravenous treatment (more than 100 ml/12hrs), in any of the following situations: 1) a medical practitioner's office, suite, home, tent or vehicle; 2) IV clinics or any clinic/treatment room or center outside of a hospital facility unless a clinical diagnostic investigation or surgical procedure has been performed; 3) event organizers' medical facility, tent, first aid station, or start-finish line facility.
