

UNITED STATES EQUESTRIAN FEDERATION AREA SELECTION PROCEDURES 2025 USEF EVENTING YOUNG RIDER CHAMPIONSHIPS March 19, 2025 – v.1

1. Observation Events:

- Athletes are expected to compete at one or more of the Observation Events at the FEI level they
 intend to compete at Championships. A list of Observation Events by Area can be found in
 Appendix 2 of this document.
- For those Areas that do not have Observation Events, declared Athletes must notify the Area Young Rider Coordinator by May 1, 2025, of their planned competition schedule leading up to the Championships.

2. Selection Process:

- The Area Selectors will utilize the bellow factors in selecting their Athletes for the Nominated Entry, Definite Entry, and Team and/or Individual spots, in no order of priority:
 - Within the Qualifying Period, the overall performance and soundness of the Athlete/Horse combination in competition with emphasis on dressage scores, current fitness, cross country, and show jumping performance: jumping without faults and/or incurring time penalties, boldness, rideability, and speed with priority given to Selection Trials designated by the respective Area.
 - Previous experience, within the Qualifying Period, of the Athlete/Horse combination; preference may be given to Athlete/Horse combinations who have demonstrated ability to succeed in multiple Eventing competitions. The depth of experience the Athlete/Horse combination has at multiple venues. Preference will be given to candidates who meet the USEF qualification as an Athlete/Horse combination.
 - Ranking Logic list found on the Championships website page. Details on ranking logic are located in Section 5 of these Procedures.
 - The Athlete's fitness.
 - The Athlete/Horse combination's will to win and the suitability of the combination to win or contribute to a Team placing at the Championships.
 - o Any yellow cards, or other disciplinary actions, will be taken into consideration.

3. Additional Requirements:

- Athletes are responsible for completing all entries to the FEI event(s) before the closing date for any Selection or Observation Trials they plan to attend and the Championships. A complete entry includes but is not limited to the submission of all paperwork, including FEI portal requirements, stabling requests, and paying all fees. Athletes are responsible for keeping track of their Athlete/Horse qualifications and performance.
- The Athlete must sign an agreement acknowledging the financial responsibility of representing their Area at the championship event.
- Athletes are expected to be team players and to be present for the entire Championships to support the Area Team, regardless of individual status in the Championships, and to abide by the rules established by the Area Chef d'Equipe and/or Team Coach that are set forth in the team meetings to be held at the Championships regarding Athlete conduct, social media use, and Horse welfare. Additionally, Athletes are expected to return all funds provided by the Area to purchase team equipment and/or gear if the Athlete is excused from the Area team for violating USEF, USEA, FEI, or Area team rules.

• Each candidate will be required to complete seven (7) volunteer hours within the Qualifying Period. These hours must be completed at a USEA Recognized Event. Hours must be recorded via the USEA Volunteer Incentive Program Dashboard (eventingvolunteers.com).

4. Ranking Logic:

- The Athlete/Horse combination's performance during the entire Qualifying Period will be evaluated with a focus on no more than the last six (6) runs at Training level and above. If an Athlete/Horse combination does not have six (6) runs together at Training level or above, only those runs as a combination will be considered.
- The ranking, modeled off the FEI and EquiRatings ranking logic, takes into consideration fitness
 at the time of competition, boldness, and rideability based on the overall performance of the
 Athlete/Horse combination in competition with an emphasis on dressage scores, cross country
 and show jumping performance: jumping without faults and/or incurring time penalties and falls.
- There are times when a ranking is the result of a negative performance that can be justified. Athletes are encouraged to send a letter to explain any extenuating circumstances or factors for the Selectors to consider. Examples include: time faults as a result of footing, a glance off because of a spook at fence judge, or a hold on course where you chose to Withdraw instead of waiting for a restart. Justifications should be sent while the information is fresh. Letters received after the closing date of the Championships will not be considered.
- Overall Scores and Dressage Scores are multiplied by the following factors to adjust for complexity.

CCI1*: 0.85	Training: 1.00
CCI2*-S: 0.8	T3D: 0.95
CCI2*-L: 0.75	Modified: 0.90
CCI3*-S: 0.70	Preliminary: 0.80
CCI3*-L: 0.65	Intermediate: 0.70
CCI4* (S or L): 0.60	Advance: 0.60
