


- 1 If you are a minor age 12 or younger and wish to access the USEF Network, you will need to create a fan account. When the Birth Date indicates that a minor falls within this category, you will also need either parent or legal guardian information. This will allow the primary guardian to consent to you accessing the USEF Network powered by ClipMyHorse.TV. If this is the case, you will see the following page:



- 6 They will then click on the link and be directed to the USEF Network Minor Consent page. There they can specify which email address you will use to access the USEF Network. If it is taken, they will be notified of it and be able to change it to a unique email. They will also type their name as an electronic signature verifying that they are consenting to a minor creating and using an account on the USEF Network powered by ClipMyHorse.TV.

- 7 Consent only needs to be granted once. If using the same email as the one the consent was sent to, then USEF will consider it verified. Once verified, you only need to navigate back to www.usef.org/network to be redirected to ClipMyHorse.TV to set the password for access the USEF Network. Your login email will be what the primary guardian has set it to.
- 8 If the email entered is different from the consent email, consent will be granted; however, if it is unverified, you or the primary guardian will need to navigate to the new Clip email entered and click the link in the verification email before you will be able to proceed with account activation.

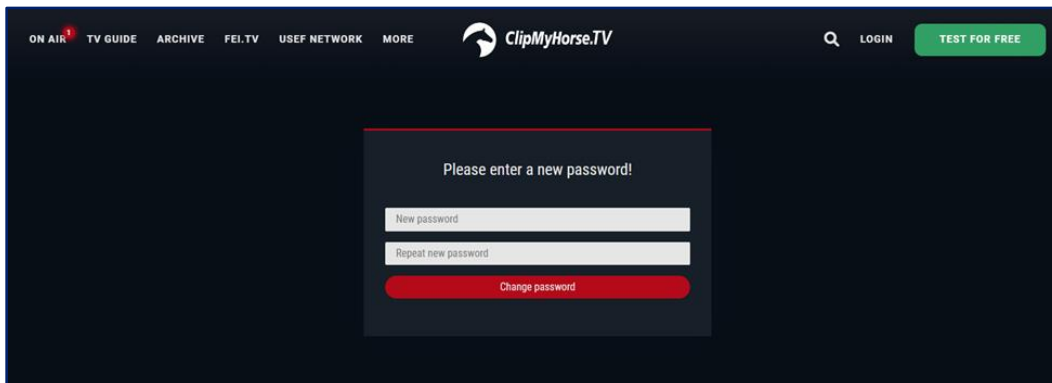

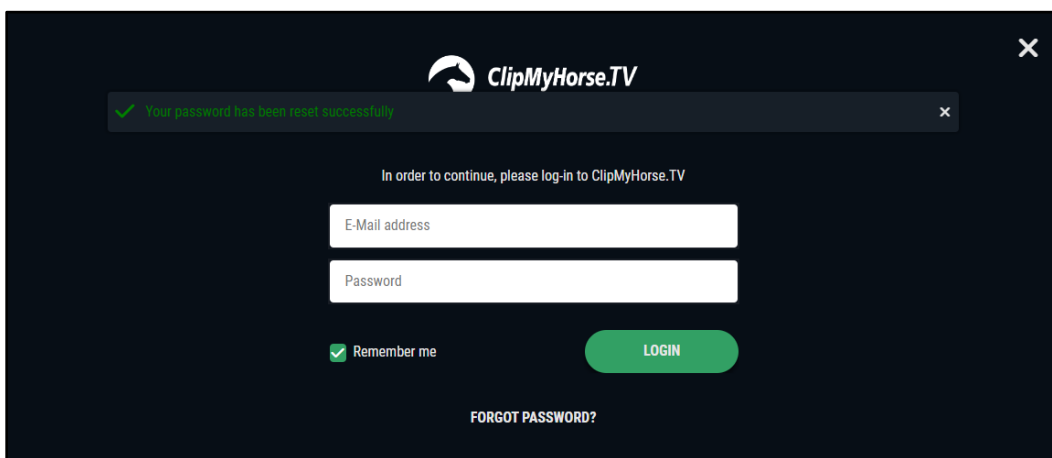

- 9 Once the email is verified, you will be redirected to ClipMyHorse.TV to set the new password to access the USEF Network.
