

## **AUTOMATIC SUSPENSIONS (Chapter 13, GR1301.4)**

The following persons/entities have failed to settle their indebtedness with the Federation and each is therefore automatically barred until further notice from participating in any Licensed Competition pursuant to Chapter 13, GR1301.4. In addition, any horses owned by the individuals/entities listed below are suspended for the same time period.

## **AUTOMATIC SUSPENSIONS (Chapter 9, GR912)**

The following persons are under suspension and are not in good standing until further notice, unless otherwise specified. A suspended person is forbidden for the time specified to hold or exercise office in the Federation or any Licensed Competition, from the privilege of taking any part whatsoever in any Licensed Competition, and is excluded from all competition grounds during Licensed Competitions as an exhibitor, participant, or spectator. Any Licensed Competition that permits a suspended person or horse to take any part whatsoever in the competition is in violation of the rules of the Federation and is subject to disciplinary action.

**AUDREY BUONICONTI**, of Newburg, MD, has failed to settle her indebtedness in connection with the Culpeper Finals Horse Show held September 27 – October 1, 2023. **AUDREY BUONICONTI**, as well as the horse **SUAVE JUAN**, are therefore automatically barred pursuant to Chapter 9, GR912, from participating in any Licensed Competition until further notice. In addition, all horses owned by **AUDREY BUONICONTI** are suspended for the same time period.

**JORDAN EVEN**, of Lake Mills, WI, has failed to settle her indebtedness in connection with the Equifest III Horse Show held August 9-13, 2023. **JORDAN EVEN**, as well as the horse **REDEMPTION**, are therefore automatically barred pursuant to Chapter 9, GR912, from participating in any Licensed Competition until further notice. In addition, all horses owned by **JORDAN EVEN** are suspended for the same time period.

**SAMANTHA FELLENZ**, of Wappingers Falls, NY, has failed to settle her indebtedness in connection with the Vermont Summer Special Horse Show held July 5-9, 2023. **SAMANTHA FELLENZ** and **ZOEY KOERNER**, as well as the horse **ZUCCHERINO**, are therefore automatically barred pursuant to Chapter 9, GR912, from participating in any Licensed Competition until further notice. In addition, all horses owned by **SAMANTHA FELLENZ** are suspended for the same time period.

In addition, all horses owned by JOANNE STEPHENSON are suspended for the same time period.
