Please be advised that the Selection Procedures for the FEI Eventing World Championships are approved and available on the US Equestrian website. Please click [here](#) to read the procedures in their entirety. The application deadline is April 15, 2022. Please read the details below prior to starting the application process.

The FEI Eventing World Championships 2022 Application is available through your online [Member Dashboard](#) on your MyUSEF account. Be sure to have your USEF Membership ID and password available. Once you sign in, click on Athlete Dashboard, then Online Applications, making sure to search for applications for '2022' then Apply for the FEI Eventing World Championships 2022 Application.

There is a lot of information in this process so please read all the documents carefully. The FEI Eventing World Championships are in Pratoni, Italy is September 14-18, 2022.

Very Important: If you have not added the horse(s) on which you plan to apply for on the application to your commonly ridden horses you will need to do so at this time by accessing your athlete dashboard under [Commonly Ridden Horses](#). If you start the application and add commonly ridden horses while the application is open, the commonly ridden horses page will open in a NEW tab in your internet browser. Once the process for adding a commonly ridden horse is complete, you will need to click the refresh button on your application to see the latest horse added to your profile. From there you will be able to proceed with the application.





Application Deadlines and Fees

Please take time to read the application paragraph in the Selection Procedures thoroughly, and note that deadlines are enforced without exception. Upon receipt of your application and fee, you and your horse owner(s) will receive an email confirming the date your application and payment was received. If you do not receive an acknowledgement of your application, IT IS YOUR OBLIGATION to contact USEF to determine if it has been received.

It is the responsibility of the applicant to ensure that the owner(s) of the horses they apply with are fully briefed on the Selection Process and Procedures.

Fee: \$70

Clean Sport

Please remember it is the Athlete's responsibility to understand and adhere to all WADA, FEI, USOPC, and USADA anti-doping protocols, policies, and procedures, and may be drug tested. FEI Registered Athletes are subject to in-competition and out-of-competition drug testing at any time. Athletes must be in possession of a current Therapeutic Use Exemption (TUE) if they wish to take medications that are prohibited under the WADA Rules. Athletes are encouraged to ensure that all medications that they take are permitted. Please contact Steven Morrissey with any questions at smorrissey@usef.org or (859) 225-7686.

All horses that are registered with the FEI or USEF shall be subject to in-competition testing in line with the FEI and USEF Rules. The FEI's philosophy is that horses must be "clean" at the time of competition. If seeking advice from a veterinarian, ensure they are a registered FEI Veterinarian and fully conversant with the FEI Veterinary Rules and the Prohibited Substance List.
